Assumption of the Risk & Waiver of Liability Relating to Coronavirus/COVID-19

As with the transmission of any communicable disease like a cold or the flu, you may be exposed to COVID-19, also known as “Coronavirus,” at any time or in any place. Despite the “Safety Guidelines” that have been established by and for the STARS Basketball Club (hereafter referred to as the “Club”) staff, athletes, and their rental facilities (including, but not limited to, TOA Sports Performance Center; 215 Gothic Court, Franklin), there is still a chance that you and your child(ren)/athlete(s) could be exposed to an illness in the facility, just as you might be at your grocery store, fitness center, or favorite restaurant.

The Club has put in place numerous preventative measures and safety guidelines to reduce the likelihood of spreading COVID-19 in the Club’s facility; however, the Club cannot guarantee that you or your athlete(s) will not become infected with COVID-19. Further, attending a basketball activity within the TOA Sports Performance Center could increase your risk and your child(ren)/athlete(s) risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and assume the risk that my child(ren)/athlete(s) and I may be exposed to or infected by COVID-19 by attending a basketball activity at the TOA Sports Performance Center, and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at a basketball activity within the TOA Sports Performance Center may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, Club volunteers, and Club participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren)/athlete(s) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren)/athlete(s) may experience or incur in connection with my team’s attendance at the Club’s facility.

On my behalf, and on behalf of my child(ren)/athlete(s), I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any basketball activity hosted at the TOA Sports Performance Center.
